# CONTEST RULES

This Contest is brought to you by the Calgary Wranglers, an AHL team owned by Calgary Sports and Entertainment Corporation ("**CSEC**") and the Alberta Chrysler Dealers Advertising Association ("**DAA**"). **NO PURCHASE NECESSARY.** To determine if you can participate, see the eligibility section below.
